# **INDIVIDUAL DOG REGISTRATION APPLICATION**

This application is only for dogs with no prior NAMASCUSA Registration  
The following rules must be followed completely for this application to be accepted.

**Print CLEARLY or type, use only blue or black ink.**

## **Rules:**

- 1) An ASCA and/or AKC registered Australian Shepherd will not be registered as a Miniature Australian Shepherd unless it has an NSDR MA number.
- 2) Either the sire and/or dam must be registered with NAMASCUSA, MASCA or NSDR as a Miniature Australian Shepherd for the dog to be eligible for registration via an "IDR".
- 3) Once a dog is registered with NAMASCUSA, via an IDR application, its offspring and generations to come can only be registered using a litter application.
- 4) The dog/puppy is not eligible to be registered using an IDR application if its litter is already registered with NAMASCUSA. If the litter is registered with NAMASCUSA, the dog/puppy must be registered using the "Yellow" litter registration individual dog application.
- 5) If the dog or its parents are registered with a registry other than NAMASCUSA, enclose a copy of their registration certificate. The NSDR temporary registration letter is only accepted with copies of the parents registration certificates. An application to another registry will not be accepted as a registration certificate.
- 6) Provide a copy of a 3-generation pedigree, complete with all dog's registration numbers and registered names.
- 7) Enclose three (3) color photos of the dog with the application. Full body view of the right side, left side and front.
- 8) Once a dog is registered with NAMASCUSA, the registered name will not be changed. Correction to spelling or punctuation may be made if requested by the owner of the dog within 60 days of certificate issue date and prior to any offspring being registered to said dog. The signature of the owner(s) must accompany the corrections. Punctuation or spelling errors made by the applicant require a change fee of \$10. Errors made by the Registrar will be corrected at no charge. Return the original certificate to the registry with the corrections noted.
- 9) Any dog whose registration application is denied may appeal to the NAMASCUSA Board of Directors.

## **Registration Fee:**

Up to 12 months of age - \$10, 12-24 months of age - \$20, Over 24 months of age - \$40

Registration Fee must accompany the application. **Fees are doubled for non-members.**
