HARDSHIP DOG REGISTRATION APPLICATION

This application is only for dogs with no prior NAMASCUSA/MASCA/NSDR Registration

The following rules must be followed completely for this application to be accepted.

Print CLEARLY or type, use only blue or black ink.

Rules:

- 1) An ASDR and/or APRI registered Australian Shepherd will not be registered as a Miniature Australian Shepherd unless it has an ASDR or APRI miniature Australian Shepherd number.
- 2) If the sire and dam are registered with NAMASCUSA, MASCA or NSDR as a Miniature Australian Shepherd, the dog can not be eligible for registration via a Hardship Registration.
- 3) The dog is not eligible to be registered using a Hardship application if its litter is already registered or can be registered with NAMASCUSA. If the litter is registered or can be registered with NAMASCUSA, the dog must be registered using the **“Yellow”** litter registration individual dog application.
- 4) If the dog or its parents are registered with a registry other than NAMASCUSA, enclose copies of their registration certificates. The NSDR temporary registration letter is only accepted with copies of the parents registration certificates. An application to ASDR or APRI will not be accepted as a registration certificate.
- 5) Provide a copy of a 3-generation pedigree (behind the dog), complete with all dog's registration numbers and registered names. The dog must go back to NAMASCUSA, MASCA or NSDR registered miniature Australian Shepherds within the three generations; with **1/8 of the pedigree going back to the NAMASCUSA, MASCA or NSDR registered miniature Australian Shepherd.**
- 6) Enclose 3 pictures of the dog: Left side standing, Right side standing, Front view. If the dog is 12 months or older you must include dogs height.
- 7) If the dog is currently registered with an approved registry, the name cannot be changed when applying for the hardship registration.
- 8) Once a dog is registered with NAMASCUSA, the registered name can not be changed, except as provided for by the Registry Rules, Name Change Rules, and by Appeal to the NAMASCUSA Board of Directors. The registered name will not be changed (if dog has earned show points, titles or produced or sired a litter under that name). Correction to spelling or punctuation maybe made if requested by the owner of the dog within 60 days of certificate issue date and prior to any offspring being registered to said dog. The signature of the owner(s) must accompany the corrections. Punctuation or spelling errors made by the applicant require a change fee of \$10. Errors made by the Registrar will be corrected at no charge. Return the original certificate to the registry with the corrections noted.
- 9) The dog must be micro-chipped or tattooed, and said information provided on the application for Hardship Registration.
- 10) The application will be reviewed by the Registrar and an elected board member before the registration will be issued. The dog must conform to the NAMASCUSA Breed Standard.
